

## AMENDMENT TO SUPPLY AGREEMENT

(Sourcing Agreement for Purchase of Essential Oil)

## RECITALS

dōTERRA Global Limited, fka doTERRA GH Ireland Limited, is a limited liability company governed by Irish law, registered in Ireland with the Register of Companies under number 636906, having its registered office at 32 Molesworth Street, Dublin 2, Ireland, or assignee within the dōTERRA organization or companies, (hereinafter "dōTERRA" or "Purchaser");

GEM Aromatics Limited, a public limited company organised and existing under the Laws of The Republic of India being CIN – U24246MH1997PLC111057, with registered office at A/410, Kailash Complex, Vikhroli – Powai Link Road, Park Site, Vikhroli (West), Mumbai – 400 -079 in the city of Mumbai, State of Maharashtra (India), (hereinafter referred to as "Gem," or "Supplier");

Purchaser and Supplier hereinafter referred to as a "Party" and, jointly, as the "Parties".

## Whereas:

Purchaser and GEM entered into a Supply Agreement, on or about April 11, 2019.

- The parties have enjoyed a fruitful relationship that has been mutually beneficial.
- The parties desire to continue their relationship and to enter a longer-term agreement.

NOW THEREFORE, the parties agree as follows:

- 1. The parties desire to extend the agreement until 31st December 2028 on the following terms:
  - a. For each of the calendar years 2024 and 2025, Purchaser shall purchase at least \$5,000,000 USD of essential oils from GEM. For the calendar years 2026, 2027, and 2028, the minimum purchase value or quantity shall be established through mutual agreement between both parties, taking into consideration the anticipated future requirements.
  - b. Each year, the parties will negotiate the terms as set forth in Appendix 1 to the original agreement which determines, among other details found in Appendix 1, the identity of oils and the Annual Minimum Quantities for each oil to be purchased for the subsequent year. In the event, the parties are unable to agree to terms related to the identity of the oil and Annual Minimum Quantities, for a given year, either party may terminate the agreement.
  - c. Provision 11.2 of the agreement is deleted from the agreement.
  - d. All terms and conditions stipulated in the previous Supply Agreement dated April
     11, 2019, remain unchanged and applicable unless modified by this document.
